5) Financial terms and conditions:

- Tutor fees are payable for 12 months per year.
- Tutor fees are to be paid in advance, either monthly, per term or once off.
- Payments are to be made into the bank account provided, on or before the 28th of the previous month.
- Registration fees are non- returnable when the student leaves.
- Accounts in arrears for more than 30 days will be liable to 15% interest payable.
- Should an account be overdue, no tutoring will be provided to the student until an arrangement was made in writing, and approved by The Button Foundation management.

6) Violation of contract:

In case the terms and conditions of this contract are breached, the Button Foundation may in its own discretion:

1. Deny provision of tutoring services to the student until violation has been settled.
2. Claim damage compensation in case of loss.
3. Take any fitting legal steps.

7) Legal costs:

In case the account holder does not pay the fees, and legal steps are taken, the account holder will be held responsible for any legal costs, lawyers-fees, and any further fees involved.

8) Cancellation:

The accountholder acknowledges that ninety (90) calendar-days notice will be required in case the student will be removed.

In case notice was not given in time, accountholder will remain accountable for fees up until the end of notice period, and only once paid, will the student's books be returned.
