Terms and Conditions for Revision Learners

We hereby confirm that we are willing to accept your child into Purpose College as a revision learner, under the following terms and conditions.

1. The parents/sponsors have been made aware that Healing Wings is first and foremost a rehabilitation program and that the main point of concern for their child is of a therapeutic nature. Healing Wings admission policy states that all children must attend school while in treatment at the Youth Centre. This is non-negotiable and should the parents/sponsors wish their child take a sabbatical from school, their child will not be admitted into the Healing Wings program.
2. Parents/sponsors of revision learners will be billed 60% of Purpose College original school fees (as seen below), as well as full stationery and full book costs. This fee covers their child's space/chair on the premises, schooling and all it entails, as well as internet usage.
3. The parents/sponsors acknowledge and accept that their child will attend school as with all other learners but will not be registered with the DOE or receive a report. Their child will therefore not progress to the next year.
4. The parents/sponsors acknowledge and accept that all school fees must be paid into the Purpose College account, and not the Healing Wings account. Account queries must be forwarded to accounts@purposecollege.co.za

FINANCIAL INFORMATION:

- School fees indicated here are already calculated at 60% of Purpose College full fees.
- Stationery fees are charged at full cost – must be paid immediately.
- Art fees (Grade 10 – 12) are charged at full cost – must be paid immediately.

- Educational fees are separate from therapeutic/tuck shop fees and **must** be paid into the Purpose College bank account, listed below.
- Invoices are sent on the 1st of each month for the following month. Payment is due before the end of the month in which the invoice was sent.
(le March invoice will be sent on the 1st February and is payable before the 1st March.)
- Statements are also sent out on the 1st of each month.
- Payment for the first full invoice must be received on or before the day of admission to Healing Wings (even if the child arrives during school holidays).
- School fees are calculated per term but can be paid over 11 months, per term, or per year.
- All educational fees are the responsibility of the sponsor/acountholder.
- Additional unforeseen costs (including but not limited to damage to property, breakages) will be billed to and covered by the sponsor/acountholder.
- 10% interest will be charged for accounts past 60 days overdue.
- Accounts past 90 days overdue will be handed over for collection without notice. Legal fees will be added to outstanding amounts.
- Fees are payable in advance, are non-refundable, and should the learner leave for any reason whatsoever (including but not limited to absconding – see below – or expulsion) prior to the program being completed, no monies are liable to be refunded. Purpose College reserves the right to claim recovery of any amount still outstanding, notwithstanding the early termination thereof.
- Leaving prior to the completion of a program period constitutes as absconding and all related school fees will be forfeited.
- In the event the learner is not committing to their education, the fees are still payable.
